Nature of the study. You are invited to participate in a study which involves choosing what you think is a more natural expression for the object represented by the picture. You will need to make a choice between two videos. Your responses will be recorded. Your session should last for around 8 minutes. You will be given full instructions shortly.

Compensation. You will be paid £2 for your participation in this study.

Risks and benefits. There are no known risks to participation in this study. Other than the payment mentioned, there are no tangible benefits to you, however you will be contributing to our knowledge about language.

Confidentiality and use of data. All the information we collect during the course of the research will be processed in accordance with Data Protection Law. In order to safeguard your privacy, we will never share personal information (like your name) with anyone outside the research team. Your data will be referred to by a unique participant number rather than by name). Please note that we will temporarily collect your Prolific ID to prevent repeat participation, however we will never share this information with anyone outside the research team. We will store any personal data (i.e., worker ID) using the University of Edinburgh's secure encrypted storage service. The anonymised data collected during this study will be used for research purposes.

What are my data protection rights? The University of Edinburgh is a Data Controller for the information you provide. You have the right to access information held about you. Your right of access can be exercised in accordance with Data Protection Law. You also have other rights including rights of correction, erasure and objection.
